### **NOTICE OF HEARING**

### **PROPOSED AMENDMENTS TO RULE 29**

At the request of the Plymouth Rock Assurance Corporation, and pursuant to the provisions of Article X of the Plan of Operation, the Commissioner of Insurance has issued a Notice of Hearing to afford all interested parties an opportunity to provide oral or written comment on proposed amendments to Rule 29 – Assignment Process of CAR’s Rules of Operation. **NOTICE OF HEARING**

Docket No. C2018-02

At the request of the Plymouth Rock Assurance Corporation, pursuant to the provisions of Article X of the Plan of Operation of the Commonwealth Automobile Reinsurers (“CAR”), a hearing will be held on January 24, 2019, at 10:00 a.m. at the Offices of the Division of Insurance (“Division”), Hearing Room 1-E, 1000 Washington Street, Boston, MA 02118. The purpose of the hearing is to afford all interested parties an opportunity to provide oral and written testimony regarding amendments to Rule 29 of the CAR Rules of Operation, approved by the CAR Governing Committee on November 14, 2018 and filed with the Division on November 26, 2018. The proceeding has been designated as Docket No. C2018-02.

The proposed amendment to Rule 29 revises the participation credits for CAR members writing on a voluntary basis exposures in specific territory and operator classes as shown on the table in CAR Rule 29.E.3. The new credit factors will apply to policies with effective dates of April 1, 2019 and subsequent.

Any person who wishes to offer oral comment on the proposed amendment at the hearing is requested to submit a Notice of Intent to Comment no later than January 22, 2019. All other interested persons will be heard after those who notify the Division in advance.
